**DEFENDANT'S SUPPLEMENTAL REPLY TO STATE'S MOTION
FOR DETERMINATION OF NEW TRIAL DATE**


COMES NOW the Defendant, CASEY MARIE ANTHONY, by and through her attorneys JOSE A. BAEZ and ANDREA D. LYON, and respectfully submits to the Court the following Supplemental Reply to the State's Motion for Determination of a New Trial Date. In support of which, Miss Anthony states as follows:

- 1) On June 19, 2009, the prosecution filed a motion in Miss Anthony's check fraud case asking the Court to set a trial date.
- 2) On July 16, 2009, Miss Anthony filed a Reply to the prosecution's motion, asking the Court to deny the state's request on the grounds that scheduling the check fraud trial before Miss Anthony's murder trial, case no. 482008-CF-0013331-O, would unduly burden Miss Anthony's ability to defend herself in either trial.
- 3) At a hearing to argue the motion and reply on August 21, 2009, Assistant State Attorney George appeared to concede that the prosecution was not arguing its case on speedy trial grounds, Fla. Stat. 918.015, but rather in an effort to get the check fraud case back on track.

- 4) With this understanding, if the Court should decide to set a trial date in her check fraud case, Miss Anthony respectfully suggests a trial date in November, 2010. Setting a trial date for this time would ensure that it take place after Miss Anthony's murder trial, currently scheduled to begin in June of 2010, and would give the prosecution the definite date it seeks.
